Prior to the Identification Division conducting latent fingerprint examinations of the blue boxes containing the writing on the inside and of the three by five cards, it is requested that the laboratory photograph the writing in order that known handwriting of individuals submitted at a later date may be compared with the handwriting contained thereon. At this time there is no known handwriting available but individuals have been subpoenaed to supply the same.

The FBI Identification Division is requested to conduct latent fingerprint examinations of the outside and inside of all blue boxes submitted, with the exception of the outside of the two that have already been examined. The Identification Division is also requested to conduct latent fingerprint examinations of the enclosed three by five cards. If any latent fingerprints are developed, compare them with the fingerprints of the above individuals if available. Also compare the seven latent fingerprints that are enclosed with the fingerprints of the above listed individuals. -
