The writer identified herself as a former student at the University of Chicago, having entered in 1948 and having remained there for five years. The writer stated that while there she had been a member of the Communist Party and of the Labor Youth League. She further stated that the subject had arrived at the University of Chicago with a personal letter of recommendation from ______ of the Massachusetts Institute of Technology, who recommended him most highly. She went on to say that the subject thereafter had been a Communist or at least in the Labor Youth League.



The Chicago, Illinois, Office of this Bureau subsequently advised that confidential informants who have furnished reliable information in the past, and who are generally familiar with Communist Party and front group activities in the vicinity of the University of Chicago, reported that <u>Alan Levi Tritter</u> was unknown to them, Records of the Chicago Police Department and the Chicago Credit Bureau, Incorporated, both failed to reflect any information identifiable with Tritter.

In view of the above, no further investigation was conducted by this Bureau.

TRITTER stated that he resides at 33 Stearns Road, Brookline, Mass., and is presently on leave of absence from the University of Chicago Law School where he is a student. At the present time, he is a staff member of Lincoln Laboratory, also known as Project Lincoln, operated by the Mass. Institute of Technology at Lexington, Mass.

TRITTYR related that _______ and he had been members of the Independent Student League at the University of Chicago and he described this organization as a conservative campus group which was opposed to the Labor Youth League and the Communist Party. He pointed out that the Independent Student League was formed in 1948 to oppose the American Veterans Committee at the University of Chicago. He further stated that the members of the Labor Youth League were very vocal and vehement in denouncing the Independent Student League.

TRITTER commented further that while he was a student at Brookline High, Brookline, Mass., he had taken a mathematics course on <u>Saturdays</u> at the Mass. Institute of Technology unler He said he knew that ______ is under state indictment in Massachusetts for activities in the Communist Party and that he, TRITTER, certainly did not share ______ alleged views about the <u>Communist Party</u>. He further contended that his association with was purely on an academic plane and that their contacts were very infrequent.

Inasmuch as TRITTER is presently employed at Lincoln Laboratory, a key facility, which is the responsibility of the U. S. Air Force, available data concerning TRITTER was brought to the attention of DSI, on April 6, 1956. No further action is contemplated by this office concerning TRITTER at this time.

Reference is made to your letter of May 11, 1956 concerning the captioned individual. There is being transmitted herewith to you a copy of the report of Special Agent dated February 10, 1955, at Roston, goncerning Tritter.

Our Chicago Office has advised that data concerning Tritter is limited to that contained in the aforementioned report.

Tritter was interviewed by Special Agents of the Federal Bureau of Investigation on March 10 1007 at Boston concerning and concerning whom inquiry was being made under the character of security of Covernment Employees.

It is noted that the names of _______ and Tritter, along with others, were set forth in an anonymous letter which is described in the above-mentioned report. In this anonymous letter it was alleged that ______ and Tritter, as well as others in the Chicago area, were interested in the Communist Party.

When interviewed Tritter said that had attended the University of Chicago with him and that all three had been members of the Independent Student League at the University of Chicago. Tritter described the Independent Student League as a conservative campus group which was opposed to the Communist Party and the Labor Youth League. Tritter further stated that members of the Labor Youth League were very vocal in denouncing the Independent Student League.

Tritter also stated that ______ were both opposed to the Communist Party and the labor Youth League. Tritter stated, however, that he had heard a rumor which he did not believe that _____ was a homosexual.

It is to be noted further that when Tritter was interviewed on March 19, 1956 he commented that while he had been a student at Brookline High School, Brookline. <u>Massachusetts. he had taken a Mathematics course on</u> Saturdays under _______ at the Massachusetts Institute of Technology at <u>Cambridge. Massachusetts. Tritter</u> also commented that he knew that _______ in <u>Massachusetts for</u> activities in <u>Connection with the Communist Party</u>, and that he, Tritten certainly did not share _______ alleged views about the Communist Party.


For your further information no investigation concerning Tritter is being conducted or contemplated at this time by this office.
