Lost and Stray Animals

This listing is a public service to assist in finding lost pets and in selection of unclaimed impounded animals desired as pets, for which only a nominal pound fee (including license where required) is collected. This is an opportunity for all interested persons to save an animal which otherwise may be destroyed. These animals are at the two Valley shelters open to the public every day, 8 a.m. to 5 p.m., except Sundays and holidays. Owners may claim their pets any time within seven days after impounding. On the eighth day, impounded animals are available to the public. Unclaimed pets are available for a minimum of only one day, the shelter advises.

The manager at the Animal Shelter points out it is not feasible to make contact by telephone, and persons seeking lost pets or desiring to obtain a pet are requested to come to the shelter for that purpose.

NOTE: Information below is listed in the following order: Breed (X mixed), kennel tag number, sex, color, other identifications, plus address from which animal has been impounded. The East Valley Shelter is at 13131 Sherman Way, North Hollywood.
