## USF To Rule Today On Whistler's Fate

TAMPA - University of South Florida officials said yesterday they will decide today if blind student Joe Engressia will be dismissed for allegedly defrauding telephone companies.

Engressia, an electrical engineering junior student from Miami, faces expulsion or probation for using a whistling technique to place free long distance telephone calls for fellow students.

Dr. Herbert Wunderlich, USF vice president and dean of student affairs, said he will announce his decision today after hearing a recommendation from the board of discipline and appeals.

THE NINE - MEMBER board met until late yesterday to evaluate testimony presented during a two-hour hearing.

Engressia, blind from birth, is appealing a USF offer to withdraw and lose credit for the current term or be suspended, If Engressia had withdrawn there would be no official entry against his college record but a suspension would have meant an unfavorable entry on his USF records.

Mrs. Josef Engressia, mother of the student, said that if the ruling is unfavorable and her son is expelled, she will appeal the case to the State Board of Regents or seek civil court action.

DURING YESTERDAY'S well - attended hearing, Engressia's counsel, student protest leader Paul Wallace.

sought to prove the blind student did not commit larceny under Florida law when the free calls were made.

Wallace argued that Engressia did not permanently deprive the telephone company of its property and he did not steal telephone company equipment.

During his testimony, Engressia declared, "It all started with a bet and the students practically forced me begged me to make the calls. I stopped on my own initiative.

"I'm not ashamed of the feat. It was a mistake and I'm sorry I did it, but not because I got caught. My action was totally irresponsible and it shouldn't be condoned, but I don't think I should be penalized for a first offense so severely that it practically cuts off my education."
